ZICSEAMS and the other similar matters, into which I will go later, made me concluded that FERIGER was active for the Israeli Intelligence Service or sense other Israeli office. During the winter of 1945-1946, ETCHMANN was a prisoner in a U.S. Pow cump at Rimini, Italy, EX together with former Gestapo chief in Rome, KAPPLER, and the former Gestapo chief in Milan, an ex-Marvel officer (n.w.) That winter, both EICHMAN and the ex-Naval officer were transferred to another U.S. Pow camp and escaped, separately, after learning of the life sentence given KiPPLER by the Italiana.

Their escape route led from German through Innebruck to Rome. In Rome they obtained Syrian laissez-passers, money, and tickets to Syria from the Syrian Legation. The en-Mayal officer arrived in Syria in 1948 and became chief of Col. HIMAWI'S (SKISHAKLI's prodecessor) body-guard. SICHMANN arrived in Syria 1947-1948.

After his errivel, EICHMANN disessociated himself with the German military advisors who had ween brought to Syria to help fight

the Israelis and descrived himself as "Political Advisor to the Syrien Covernment." He was converted to Islam in 1948. In 1951, he came to Cairo and contacted the ex-Grand Mufti, Hajj Amin al-HUSAYNTS in an effort to obyain financial help. This he did not receive. EICHMANN was forced to leave Egypt in 1951 as he had no pormit to stay. The ORTHER was unable to state the present whereabouts of EXAMONE SICHMANN.

ETCHMANN was an early member of the SD, in the old SD-Hauptant II/lll (Juden-Referat) under Stubef HAJEN, with whom he, on HEY RICH's orders, is said to have visited Palesting in 1937. In 1936 he was in Vienna where, in order to facilitate emigration of the Jews, he organized the Zentral-stelle fuer Jusquische Auswanderer; later he was commissioned to organize similar institutions in Berlin and Prague. In 1942, HETDRICH put him in charge of a special Referat, the Resumungsreferat, with the purpose of

removing "underirable elements", primarily Jews, from certain aroas, This was under Ant IV B. For executive purposes, EICHMANN had a Sonderkommando with which he travelled about. His assistant, Stubaf CHENTRES. and several members of the Sonderlammando were SD members (as EICHMANN himself remained) while administrative details were handled largely by Gestaco personnel.

10. Presumably, EICHANN and the Sonderkomande came under the jurisdiction of MUZILER OF Amt 17, but often EICHMANN received direct orders from HIMMCER. In the case of Hungary, EICHMANN was called by MALTEMBRUNNER to liquidate the Jewish problem. There, as elsewhere, he was on the staff of the highest ranking police meetings and reported to WINKELMANN. The relations between EICHMANN and the Souderkommando 1005 under Standarton-Sushrer Paul BIOBEL, who carried out exterminations, are unclear. Apparen tly EICHMANN merely delivered the goods, while the Somierkammardo worked independently, under HIMMLER and (in part) under MUELLER. At any rate, EICHMANN was unable to tell HIMMLER in Spetember 19th exactly how many Jone had been liquidated because he lacked actual data. His estimate of h,000,000 was called too low by HIMMLER.
